COMMUNITY INVOLVEMENT

Sheppard Mullin has a strong tradition of supporting the LGBTQ community through pro bono work and charitable giving. The firm is proud to be a national sponsor of Lambda Legal and GLAAD. One of our LGBTQ partners sits on the Advisory Council of the Williams Institute, an LGBT research facility and think-tank at UCLA School of Law. In addition, Sheppard Mullin sponsors LGBTQ-related events and provides financial support to various LGBTQ community organizations.

Because of Sheppard Mullin's dedication to LGBTQ issues, GLAAD appointed Sheppard Mullin as its principal outside legal counsel from a competitive field. Pro bono matters for GLAAD

Pro bono matters with Lambda Legal have included assistance with an amicus brief opposing a challenge to an amendment to the California Education Code broadening the definition of gender to include sexual identity.
