### OVERVIEW

### Areas of Practice

In addition, Ms. Rosenthal has litigated all types of business disputes before courts and arbitration panels, including international arbitrations on claims, from corporate dissolutions to trademark infringement and fraud. She is also an experienced appellate practitioner.
