Sheppard Mullin Boosts Chicago Office With IP Partner

He will focus his practice on IP law, including patent litigation, post-grant proceedings and prosecution, with a geographic concentration on the U.S. and India. Most of his clients, Mehta said, will come from the pharmaceuticals, medical devices, consumer electronics and software industries.

Mehta's significant litigation experience encompasses all aspects of the discovery process, including defending and taking key depositions, witness preparation of senior level executives, participating in the claim construction process, preparing expert reports and all phases of pretrial preparation. His experience on the transactional side includes prosecuting patent applications and rendering freedom to operate opinions in the mechanical and electromechanical fields.

The firm noted that Mehta has a keen interest and concentration in aiding Indian companies in IP matters in the U.S., adding that he is actively engaged in educating and formulating IP strategies for his foreign clients.

Mehta earned his law degree from John Marshall Law School and his undergraduate degree in mechanical engineering from the University of Illinois.

"Manish joins Sheppard Mullin as part of our ongoing strategic goal to expand our intellectual property practice in Chicago and firmwide," Daniel N.
