## **Sheppard Mullin Lands Allen Matkins Employment Pro**

Jason A. "The increase in the labor and employment practice is a natural outgrowth of the growth in the firm generally," Halgren said. "Jason has very deep bonds with clients. Secondly, he has labor and employment expertise and a very broad practice already."

Weiss has helped employers comply with the Worker Adjustment and Retraining Notification Act and other federal and state employment laws, Sheppard Mullin said. His practice also includes preventive counseling and has helped draft and implement employee handbooks, workplace policies and employment contracts, the firm said.

Weiss has handled cases at the trial court and appellate levels in state and federal courts, Sheppard Mullin said. Additionally, he has counseled clients on issues related to Sarbanes-Oxley Act whistleblower claims, unemployment insurance claims and discrimination petitions filed with the Workers' Compensation Appeals Board.

Weiss earned his law degree from the University of Southern California, Gould School of Law.

"I am impressed with the firm's top-notch employment practice, as well as the strength and breadth of the firm's other practice areas," Weiss said in a statement. "Sheppard Mullin's successful expansion and entrepreneurial culture have also been very attractive to me."
