Sheppard Mullin Lands 3 Bingham White Collar, IP Partners

Dianne Feinstein's Judicial Advisory Committee for the Northern District of California and as an adviser to the American Law Institute on the Model Penal Code Sentencing Project.

Bowen received her bachelor's degree from Hofstra University and her law degree from the University of California at Berkeley's Boalt Hall School of Law. She is a former assistant U.S. attorney who served the central and northern districts of California.

She holds a seat on the Board of Governors of the Association of Business Trial Lawyers and the Board of the Lawyers' Committee for Civil Rights of the San Francisco Bay Area. Bowen recently completed a three-year term as a director of the San Francisco Bar Association.

Cannon received his bachelor's degree from the University of California in Berkeley, his master's from the University of Virginia and his law degree from the University of California's Hastings College of the Law.

He served as a judicial extern for Chief Judge Marilyn Hall Patel of the Northern District of California. In 2007, he served as an assistant district attorney in the Misdemeanor Trial Unit for the City and County of San Francisco. Cannon serves on the Boards of the San Francisco Architectural Heritage and The SMART Program.

"We are thrilled to be joining Sheppard Mullin," Marshall said in a statement. "The firm is doing so many things right; it has truly become a destination firm.
