## Sheppard Mullin Hires Ex-Greenberg Traurig M&A, Health Pro

Michael G. McKinnon joined Sheppard Mullin as a partner on Tuesday, the firm said. McKinnon's experience in corporate and securities law will bolster the firm's existing capabilities in Orange County, a hub for fast-growing and mature life sciences and health companies, according to the firm.

"The strength and breadth of the corporate and health care practices, coupled with the firm's California presence, were very attractive to me," McKinnon said in a statement. "I was also impressed by the firm's collegial culture and thriving Orange County office."

McKinnon joins the firm's 65-attorney Orange County office and its 150-attorney corporate practice group firmwide.

That group also added former Strategic Counsel Corp. managing partner Adam Ettinger to its Century City, California, office earlier in April, according to the firm.
