A 1992 graduate of the University of California at Berkeley, Daniels received his law degree from the University of Southern California's Gould School of Law in 1996.

He was drawn to Sheppard Mullin by the range of its practice.

"I was attracted to Sheppard Mullin's successful corporate practice group growth on the East Coast, as well as the breadth and depth of the firm's full-service capabilities throughout the U.S. and globally," Daniels said in a statement.

"I look forward to participating in the firm's efforts to continue its expansion in the New York market, and the growth of its emerging company and VC practice firmwide."

Daniels has advised companies and private equity firms in handling over \$5 billion of deals transactions, according to Shepard Mullin. He has also represented both issuers and underwriters in more than 25 IPOs and follow-on offerings, including Credit Suisse, Morgan Stanley and Oppenheimer.
