Internet Brands sought damages of 17 million. The arbitrator at JAMS issued a defense verdict in favor of Virtual Tourist on all causes of action.

Successfully defended Pacific Mercantile Bank, defeating class certification in a nationwide class action alleging violations of the Truth-in-Lending Act.

Represented LaSalle Business Credit in a breach of contract/fraud claim against Chinatrust Bank which resulted in a verdict against Chinatrust Bank in excess of \$20 million after a 30 day jury trial.
