Launched in 2017 as a pilot initiative for a national model, the VWEC offers women veteran business owners a CEO suite of services, from a renowned female exclusive co-working space and tailored networking opportunities to a range of critical business support services. The center engages a broad range of women veteran business owners and is designed to create measurable, socio-economic impact by promoting entrepreneurship and economic development focused on increased revenue generation, access to growth capital, collaborative contracting opportunities, and the development of social capital via key community connections.

Sheppard Mullin has a long tradition of providing legal services to people and community organizations who could otherwise not afford access to legal representation. Attorneys and staff are encouraged to contribute to their communities in many ways, including through the provision of pro bono legal services.

Veterans At Sheppard is an affinity group that strives to positively impact the veteran community by encouraging Sheppard Mullin attorneys and staff to participate in pro bono projects that serve veterans and their families; foster the success and development of veterans in the legal field; lead outreach initiatives to serve veterans in the community; raise awareness of topics, experiences and skills unique to veterans; participate in job fairs and events designed to integrate veterans into the workforce; and partner with clients and other organizations to serve the needs of veterans.
